4 **Part I. Program History**

5 **A. Purpose**

6 A campus-wide Data Science Working Group (DSWG) was formed in 2016 to foster data science
7 research on the University of Delaware campus. The DSWG organized several meetings and
8 events over the course of 2017, and produced a white paper in autumn 2017. Those events, in
9 no small part, inspired this degree program. The examples presented in the events made it
10 clear that successful data science programs involve collaboration across multiple disciplines:
11 generally this means statistics, computer and information sciences, and mathematics together
12 with domain or application areas.

13 Data science is one of the fastest growing sectors in the US. According to “The QUANT CRUNCH
14 How the demand for data science skills is disrupting the job market”, there were more than
15 2,350,000 job listings for Data Science and Analytics (CSA) in 2015; and the demand for DSA
16 jobs is projected to grow by 15% over the following five years, which translates to additional
17 364,000 new job postings. From “Investing in America’s data science and analytics talent: The
18 case for action,” a BHEF/PWC report (pwc.com/us/dsa-skills), there were 58,151 ads for data
19 science and analytics jobs in the Philadelphia-Camden-Wilmington area in 2015 alone. In that
20 year, there were a similar number in Seattle, and around 70,000 in each of the Boston, Dallas
21 and Atlanta. In the larger metro areas of New York, Chicago, Los Angeles, San Francisco, and
22 Washington DC combined to have postings of about 750,000 such positions. It may be that this
23 is at the upper end for estimates for jobs, but there is little doubt that these staggering
24 numbers of positions are difficult for organizations to fill.

25

26 According to the global management consulting firm McKinsey, data-driven technologies will
27 bring an additional \$300 billion of value to the U.S. health care sector alone, and by 2020, 1.5
28 million more "data-savvy managers" will be needed to capitalize on the potential of data, “big”
29 and otherwise. (Manyika, J. et al., 2011, “Big data: The next frontier for innovation, competition, and
30 productivity.” McKinsey Global Institute, <http://www.mckinsey.com>).

31

32 The importance of data science was recognized in the "Final Report from the National Science
33 Foundation Computer and Information Science and Engineering Advisory Committee Data
34 Science Working Group" (<https://www.nsf.gov/cise/ac-data-science-report>). Their
35 recommendations include the creation of data science centers; to support the design and
36 development of data science pedagogy and curricula; and to invest in both national and
37 institutional infrastructure to support emerging Data Science research and education programs.

38

39 The MS in Data Science is as a professional masters with a flexible set of core requirements in
40 statistics, mathematics and computer and information sciences with a range of possible
41 application areas. It provides a solid background in the methods behind data science so that

1 our graduates can go out into their fields and work well with data, and be better prepared for
2 the next methods to come along to work with large and/or dynamic data sets.

3
4 The program will provide both the breadth of training, and the flexibility to apply them in
5 different fields. The flexibility allows for training in different categories of positions in data
6 science: data analysts (use mathematical, statistical and modeling techniques to solve
7 problems), data engineers (design, build and maintain an organization’s data and analytical
8 infrastructure) and data scientists (create sophisticated analytical models to build new data sets
9 and derive new insights from data).

10
11 Given the interdisciplinary nature of data science, the program exploits departmental and
12 college cooperation. The main requirements of the program comprise courses from three
13 departments (and colleges): the Department of Mathematical Sciences (DMS, in Arts and
14 Science), the Department of Applied Economics and Statistics (AES, in Agriculture and Natural
15 Resources) and the Department of Computer and Information Sciences (CIS, in
16 Engineering). Two courses would be required from each department, with each having a small
17 list from which to choose. The idea of this Master of Science in Data Science is to provide a
18 foundation in these three areas, with electives in these areas or, where appropriate, electives
19 from wide range of departments to give specific domain knowledge.

20
21 ***B. Current Status***

22 The program began admitting students for Fall 2018, and is expected to be reviewed for
23 permanent status in 2023. The degree program was initially housed in the Department of
24 Mathematical Sciences, wherein physical files and administrative help were located. The
25 program moved to the Graduate College beginning the Fall 2021 semester. Though this
26 document governs the rules of the program, some current information such as events, elective
27 courses offered, and so forth can be found on the program web page at www.msds.udel.edu.

28 ***C. Degree Offered***

29 The degree awarded to those who complete this program will be a Master of Science with a
30 major in Data Science (MSDS). The MSDS is awarded by the Graduate College. The degree is
31 also offered in combination with a limited number of Bachelor degrees as a “4+1” program for
32 students who are undergraduates at UD. In that case, the background subjects are covered in
33 the undergraduate degree (either through required or elective courses), and six credits of the
34 MSDS course work count toward the Bachelor degree as described below. There is also a
35 separate dual degree program that combines the MSDS with the PhD program in either
36 Mathematics or Applied Mathematics that is described elsewhere.

37
38 **Part II. Admission**

39 ***A. Admission Requirements***

1 Applicants must submit all materials directly to the Graduate College using the online admission
2 process before admission can be considered. Admission applications are available at:
3 <https://grad.udel.edu>.

4
5 The program admission process is completed as follows: Completed applications consisting of
6 the online application, undergraduate/graduate transcripts, three letters of recommendation,
7 and the written statement of professional goals and values, are reviewed by the Executive
8 Committee. A grade point average (GPA) of at least 3.00 is preferred. Applications are
9 evaluated based on a combination of record of academic achievement, recommendations, and
10 the applicant's statement of professional goals and values. The Admissions Committee will
11 make admission decisions and assign accepted students to faculty advisors upon matriculation.

12
13 International applicants must submit official proof of English proficiency such as TOEFL or IELTS
14 scores. The recommended minimum TOEFL score is 100 and/or IELTS of 6.5.

15 16 ***B. Educational Requirements for Admission***

17 A Bachelor's degree from an accredited program is required for admission. A major in any of
18 mathematics, applied mathematics, statistics, computer science or engineering, or a field of
19 engineering is a good background for this program. The minimal educational requirements
20 outside of the above STEM majors should include at least one semester of

- 21 • multivariable calculus equivalent to UD's MATH 243 or MATH 222,
- 22 • linear algebra equivalent to UD's MATH 349,
- 23 • statistics and/or probability equivalent to UD's MATH 350 or 450, or Math 205, or STAT
24 470 or STAT 471, and
- 25 • at least two semesters of computer programming (data structures equivalent to UD's
26 CISC220 is desirable).

27
28 Additional recommended courses include

- 29 • ordinary differential equations (equivalent to UD's MATH 302 or MATH 351),
- 30 • a first numerical analysis or methods course (equivalent to UD's MATH 353 or MATH
31 426),
- 32 • an algorithms course (equivalent to UD's CISC 320),
- 33 • a logic and programming course (equivalent to UD's CISC 304),
- 34 • and both probability and statistics courses (equivalent to UD's MATH 350 and MATH
35 450, or STAT 470 and STAT 471).

36
37 The admissions committee makes a decision on the application for the MSDS degree. Since the
38 program is interdisciplinary, the executive committee will consult with participating
39 department(s) for advice on the application if needed. An advisor will be assigned to
40 matriculated students, and the first semester courses shall be approved by the advisor and
41 assistant director prior to the start of that semester.

1
2 Three letters of recommendation from individuals familiar with the candidate’s academic
3 and/or professional background and capabilities are required. Candidates must also submit a
4 personal statement describing how their academic, professional and personal background has
5 prepared them to be successful in the MSDS program, and explaining how the completion of
6 the MSDS will contribute to their professional goals.

7 ***C. Admission requirements to the Combined 4+1 Bachelor and MSDS Degree***

8 Students who wish to be admitted to the combined Bachelor/MSDS 4+1 program should
9 submit an application during the junior year of academic study toward an undergraduate
10 degree at the University of Delaware using the Graduate College on line admission application.
11 Interested students should consult with an advisor from the MSDS program about the courses
12 to be taken in order to complete the “Graduate Course Approval Form for 4+1 Admission
13 Approval” that is to be submitted with the admission application. Applicants must submit the
14 form with the on-line admission application when they select the Bachelor/MSDS 4+1 program.
15 At a minimum, the applicant must have a cumulative GPA of 3.2 and a GPA of 3.4 in their
16 undergraduate major. For the UD Bachelor degree, the applicant must have completed the
17 educational requirements listed in Section II.B by the end of the fourth year of undergraduate
18 study. Two letters of recommendation from University of Delaware faculty and academic
19 transcripts must be submitted. The TOEFL exam is required for 4+1 program international
20 student applicants as that was required when admitted to UD as an undergraduate student.

21 Applicants for the 4+1/MSDS degree program must complete the educational requirements
22 during their undergraduate degree program and the completion of the undergraduate degree.

23 ***D. Application deadlines***

24 The application deadline for Fall admission is March 1; the deadline for Spring admission is
25 November 1. Earlier applications are encouraged because space may be limited.

26 ***E. Admission Status Categories***

27 Students may be admitted into the program in one of two categories as follows.

28 1) Regular Admission: Regular status is offered to students who meet all of the
29 established entrance requirements.

30 2) Conditional Admission: Applicants are admitted conditionally if all required
31 official documents have not been received. These documents must be submitted to
32 the Graduate College by the first day of classes. Fulfilling the conditions stated on an
33 offer of conditional admission is critical. Failure to clear all stated conditions by the
34 start of graduate coursework may result in revocation of admission to the graduate
35 program.

36 ***F. University Statement***

1 Admission to the MSDS graduate program is competitive. Those who meet the stated requirements are
2 not guaranteed admission, nor are those who fail to meet all of those requirements necessarily
3 precluded from admission if they offer appropriate strengths.

4 **Part III. Academic Degree: Master of Science with a major in Data Science**
5 **(MSDS)**

6 **A. Degree Requirements**

7 A total of 33 credits is required for the degree. If the student lacks background knowledge for
8 one or more courses, prerequisite courses may need to be taken that do not count toward the
9 degree. Expected semester of course offering is given below (F = fall, S = spring, J = summer);
10 these are subject to change.

11 **1) Core Requirements:** 18 credits (See explanation of how courses in the Core list may or may not be
12 used toward elective requirements noted below):

13 At least six credits of core courses (2 courses) are required from the following list of courses in the area
14 of PROBABILISTIC AND STATISTICAL FOUNDATIONS (each course is three credits):

27 At least three credits of core courses (1 course) are required from the following list of courses in the

1 At least three credits of core courses (1 course) are required from the following list of courses in the
2 area of MATHEMATICAL AND COMPUTATIONAL FOUNDATIONS (each course is three credits):

- 3 ○ CISC 621 Algorithm Design and Analysis (F/S)
- 4 ○ \$MATH 612 Computational Methods for Equation Solving and Function Min (F)
- 5 ○ \$STAT 603 Statistical computing and optimization (convex optimization and
6 algorithms) (S)

7 Three credits (1 course) is required from the following list of courses in the area of ETHICS:

- 8 ○ PHIL 655 Ethics in Data Science and Artificial Intelligence (F)

9

10 Explanations of how courses may be applied to the core requirements:

11 *Only one of STAT 674 and CISC 637 may be taken for credit toward the degree.

12 # Only two of these courses may be applied as required courses toward the degree.

13 \$ Only one of MATH 612 and STAT 603 may be applied as required courses toward the degree.

14

15 2) Electives

16 Fifteen (15) credits of elective courses may come from a variety of courses on campus with
17 relevant application or quantitative content. A list of example courses is given in Appendix A.
18 The elective list is not meant to be exhaustive. The courses must be at the 600 level or above.
19 A course from the core lists may be chosen as an elective provided that it has not already been
20 used to satisfy the core course requirement. The electives taken by the student must be
21 approved by the advisor and the Assistant Director of the MSDS prior to registration. The
22 student's plan of study for the degree shall be approved, at the latest, by the advisor and by the
23 Assistant Director prior to the beginning of the last semester.

24 3) Non-thesis option

25 33 credits of course work are required. Up to three credits of Special Problem (866) or
26 Research (868) can be applied toward the credit total. These courses may come from
27 departments on campus or from the MSDS program. These Special Problem or Research credits
28 may come from experience on campus or in industry (e.g., internships). Special Problem or
29 Research credits must be related to the degree and must be approved by the advisor and the
30 executive committee. Valid scholarly output from such credits are presentations (oral or
31 poster), papers, reports or similar that demonstrate related work in the field.

32 4) Thesis option

33 A minimum of six credits of 869 are required for the thesis option. The University requirements
34 for master's theses shall apply to the thesis in this degree. The committee for the thesis shall
35 include three members with at least one faculty member outside of the department of the
36 advisor.

1 5) Bx/MSDS 4+1 program

2 The MSDS can be obtained in conjunction with a limited numbers of Bachelor degree programs
3 as a 4+1 combination. Here the x in Bx can be A for Arts, S for Science or other letters for other
4 degrees. At the time of writing, the Bachelor degrees available are as follows. Any of the
5 Bachelor degrees from Mathematical Sciences(DMS) may be combined with the MSDS: BA in
6 Mathematics or Mathematics Education; BS in Actuarial Sciences, Applied Mathematics,
7 Mathematics and Economics, Mathematics Education, or Quantitative Biology; or honors
8 versions of any of them, HBx. Similarly, any of the Bachelor degrees from CIS, Electrical and
9 Computer Engineering (ECE), Mechanical Engineering (ME), or Physics and Astronomy (DPA) are
10 available for combining with the MSDS as a 4+1 program. From CIS, these are: Computer
11 Science (BA, BS); Information Systems (BS); and honors versions (HBx). From ECE, these are:
12 Computer Engineering (BCpE); Electrical Engineering (BEE); and honors versions (HBx). From
13 ME, these are: Bachelor of Mechanical Engineering (BME), and the honors version (HBME).
14 From DPA, these are: BS, BA, HBS, HBA options in each of Physics or Astronomy, as well as BA
15 and HBA in Physics Education. Up to six credits from the graduate course work may be applied
16 to the Bachelor degree that come from the area of the undergraduate major. For example,
17 mathematics courses may be applied to a major from DMS, computer science courses can be
18 applied to a major from CIS, and electrical engineering courses may be applied to a major from
19 ECE.

20 Students who wish to be admitted to the Bx/MSDS 4+1 program should submit an application
21 during the junior year of academic study toward an undergraduate degree at the University of
22 Delaware as described in section II.C.

23 6) Advisor and Program of Study

24 An advisor will be assigned prior to the start of the first semester of study for the MSDS. The
25 first semester courses shall be approved by the advisor prior to the start of that semester. The
26 student and the advisor will develop a program of study; the program of study submitted to the
27 Assistant Director for approval prior to the end of the first semester of courses. For students
28 accepted into the 4+1 program, an advisor for the MSDS will be assigned prior to the end of the
29 second semester of the junior year of undergraduate study, and a program of study for the
30 MSDS shall be approved before the end of that semester.

31 7) Changes to the Program of Study

32 Students may need to alter approved programs of study due to scheduling conflicts or the
33 creation of new courses directly related to the student's goals. Students who wish to make
34 minor changes to their program of study must obtain permission from their advisor. Major
35 changes to the program of study, such as the substitution of one or more core courses, must be
36 approved by the Program Director. All changes in a previously approved program of study must
37 be approved by the Program Director.

1 8) Transfer credits

2 Up to six credits of approved courses completed at other universities may be transferred
3 toward the degree, provided that the credits have not been applied to obtain a different
4 degree. The transfer must be approved by the Executive committee, and if necessary, in
5 consultation with the department that offers the (potentially) equivalent course.

6 9) Awarding the degree

7 The MS degree is awarded by the Dean of the Graduate College. The executive committee shall
8 approve the program of study for the MSDS on the student's Application for Advanced Degree
9 (available online).

10 ***B. Timetable and satisfactory progress toward the degree***

11 1) Academic load and satisfactory progress

12 The MSDS program will follow the University of Delaware, Graduate College policy for determining
13 students' failure to make satisfactory progress towards degree requirements and time limits for
14 completion. Students may be enrolled on a full-time (9 credits per term) or part-time (fewer than 9
15 credits per term) basis.

16 2) Grade and GPA requirements

17 Students must pass all of the core courses with a minimum grade of B or better, and a grade
18 point average (GPA) of 3.25 or better in the six core courses, to continue in the program. The
19 student may repeat a core course in order to earn an acceptable grade for the degree. All
20 graduate-numbered courses taken with graduate student classification at the University of
21 Delaware are applied to the cumulative GPA. Credit hours and courses for which the grade is
22 below B- do not count toward the degree even though the grade is applied to the overall GPA.
23 Elective courses may not be repeated to apply to the degree.

24 3) Grievance procedures

25 Students concerned that they have received an unfair evaluation or have been graded
26 inappropriately may file grievances in accordance with the student guide to University of
27 Delaware policies. Students are encouraged to contact the program director prior to filing a
28 grievance.

29 **Part IV. Educational Goals and Assessment Plan**

30 ***A. Educational Goals***

31

32 1) Philosophy of the degree

33 The MS in Data Science at the University of Delaware aims to educate leaders in understanding
34 and applying modern methods of data science to analyze problems of current interest in

1 industry, government and academia. We aim to give the student a solid background in selected
2 areas and the freedom to select relevant domain area courses. The domain areas may come
3 from all over campus, from technical fields of engineering, to social science and public policy, to
4 the health sciences. The program is designed for flexibility. The following learning objectives
5 aim to achieve these goals.

6 2) Educational Goals

- 7 1. Demonstrate a mastery of foundational knowledge in data science through the
8 successful completion of a diverse range of coursework encompassing multiple areas of
9 domain *and* technical expertise.
- 10 2. Develop and apply data science techniques in one or more domain areas of interest via
11 course projects, examinations, and/or a master’s thesis.
- 12 3. Communicate data science techniques and findings to expert and non-expert audiences
13 in written, discussion, visual, and oral presentation formats.
- 14 4. Demonstrate a deep understanding of ethics in data science and related technical tools
15 through in-depth discussion and study of current ethical issues in the field.
- 16 5. Gain experiential training—via on-campus projects or external internships—in workflow
17 management, technical collaboration, and professional accountability in preparation for
18 the expectations of the workplace.

19

20 **B. Program Assessment**

21 The program will follow the Academic Program Review (APR) schedule, policies and procedures,
22 established by the Provost’s office and Faculty Senate. Data will be provided by the Office of
23 Institutional Research and Effectiveness, in conjunction with faculty/student interviews,
24 measures of scholarly productivity and alumni. Meetings will be held at least semi-annually to
25 discuss curricular changes, review data, identify actions to strengthen the program, and
26 establish timelines and assignments for responsibilities. The program will continue consultation
27 with the Center for Teaching and Assessment of Learning to periodically assess learning
28 outcomes, assessment criteria, and benchmarks for success.

7 ***A. Elective Courses***

8 The design of this degree is flexible. Courses appropriate from the main departments, as well
