HazCollect will be introduced in phases by geographic area

- However, no registrant will be denied use of the system solely based on the user's geographic location

- Phase 2, May 26, 2009
 - GA, AL, TN, LA, MS, AR, MO, SC, NC, VA, WV, MD, DE, DC, rest of FL
- Phase 3, June 8
 - WA, OR, UT, CA, NV, AZ, NM, TX, OK, CO, KS, NE, IA, IL
- Phase 4, June 22
 - ND, SD, MN, MI, IN, OH, PA, NY, NJ, CT, RI, MA, NH, VT, ME
- Phase 5, July 1, 2009
 - WY, ID, MT, GU, PR, VI, American territories in Pacific



HazCollect, the NWS's All-Hazards Emergency Message Collection System, is a comprehensive national solution for the centralized collection and efficient distribution of Non-Weather Emergency Messages (NWEMs). NWEMs created by government officials with public warning authority are distributed through the NWS dissemination infrastructure, NOAA Weather Radio All Hazards, other national systems, and to the nation's Emergency Alert System (EAS).

A Non-weather Emergency Message (NWEM) is a specialized form of an OASIS Common Alerting Protocol (CAP) alert that is communicated to the HazCollect server via FEMA's Disaster Management Open Platform for Emergency Networks (DM-OPEN) interoperability infrastructure. FEMA's Disaster Management Interoperability Service (DMIS) Desktop Tools incorporates an NWEM authoring tool for the use of warning authorities, although the authoring tool is not available for use until the HazCollect registration process is completed. Third party developers may also develop authoring tools utilizing DM-OPEN's NWEM Application Programming Interface (API).

Suggested Sequence of Events

- 1. Complete Chapter 1 of the training to learn more about HazCollect and decide if you wish to pursue.

- 4. Once notified that COG has been established and training has been completed, apply for HazCollect access.
- 5. While waiting for approval, develop your implementation strategy per Chapter 5
- 6. Install and configure NWEM authoring software, such as DMIS Tools
- 7. Once HazCollect access has been approved, configure your message templates
- 8. Exercise

4. Warning Best Practices

A considerable body of literature exists regarding what is generally termed "public risk communication." This chapter focuses on best practices with respect to the warning or alerting decision, message content, and message style elements. These elements are described in the context of the steps individuals follow in response to receiving an emergency message. The purpose is to ensure that your emergency messages will be as effective as possible.

The goal of this chapter is to assist you in making the decision to warn, and in composing well written warnings and alerts. Once you have completed this chapter, you will be able to:

- · apply understanding of the social context for effective warnings and alerts;
- use Job Aid #2, Warning Decision Tree, to assist you in deciding when warnings and alerts are appropriate;
- write NWEM hazard descriptions to include essential information (who, what, when, and where);
- write NWEM public protective instructions to include essential information (why and how);
