

**The Economics of Offshore Wind Power**

I present results on a study of the cost of offshore wind power in the context of uncertainty and of foregone alternatives. I discuss limitations to the valuation of damages from carbon emissions, the cost or benefit of employment under conditions of structural unemployment, and how to analyze future costs given technology development and learning.
