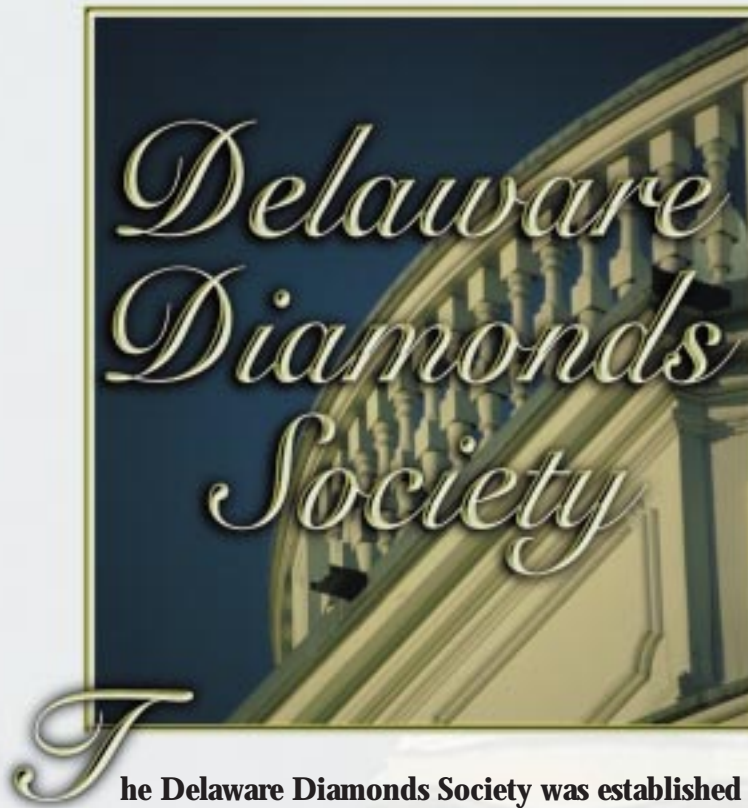

The Delaware Diamonds Society was established in 1991 to recognize and honor the University's most generous alumni and friends. Donors who make an outright gift of \$5,000 or more—or who pledge to do so over a period of up to five years—are recognized as Delaware Diamonds. There are three levels of Delaware Diamonds membership:

Senior Benefactor \$25,000 and above
Benefactor \$10,000 to \$24,999
Member \$5,000 to \$9,999

Donors whose lifetime giving totals \$50,000 or more are granted membership in the Delaware Diamonds Society for life.

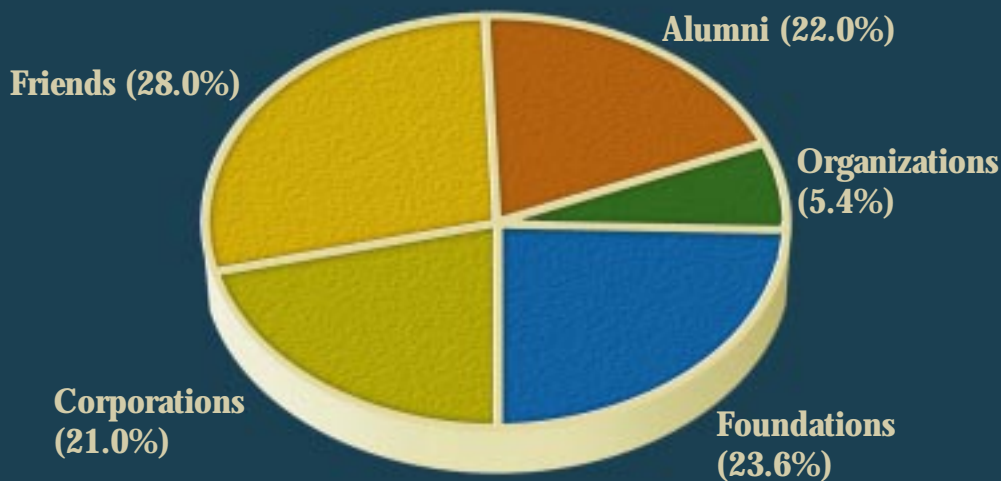
Members of the Legacy Society—those individuals who make UD part of their financial and estate plans—are also accorded membership in the Delaware Diamonds Society. Their level of membership is based upon the market value of the gift when made. These contributors are listed both as Delaware Diamonds and in the list of Legacy Society members on page 25. Legacy Society members whose gifts are in the form of a revocable bequest provision are included separately in the Legacy Society membership list.

As of July 1, 1998, the Delaware Diamonds Society included more than 950 alumni, faculty, staff, parents and friends of the University. The University owes much to the involvement of these special donors.

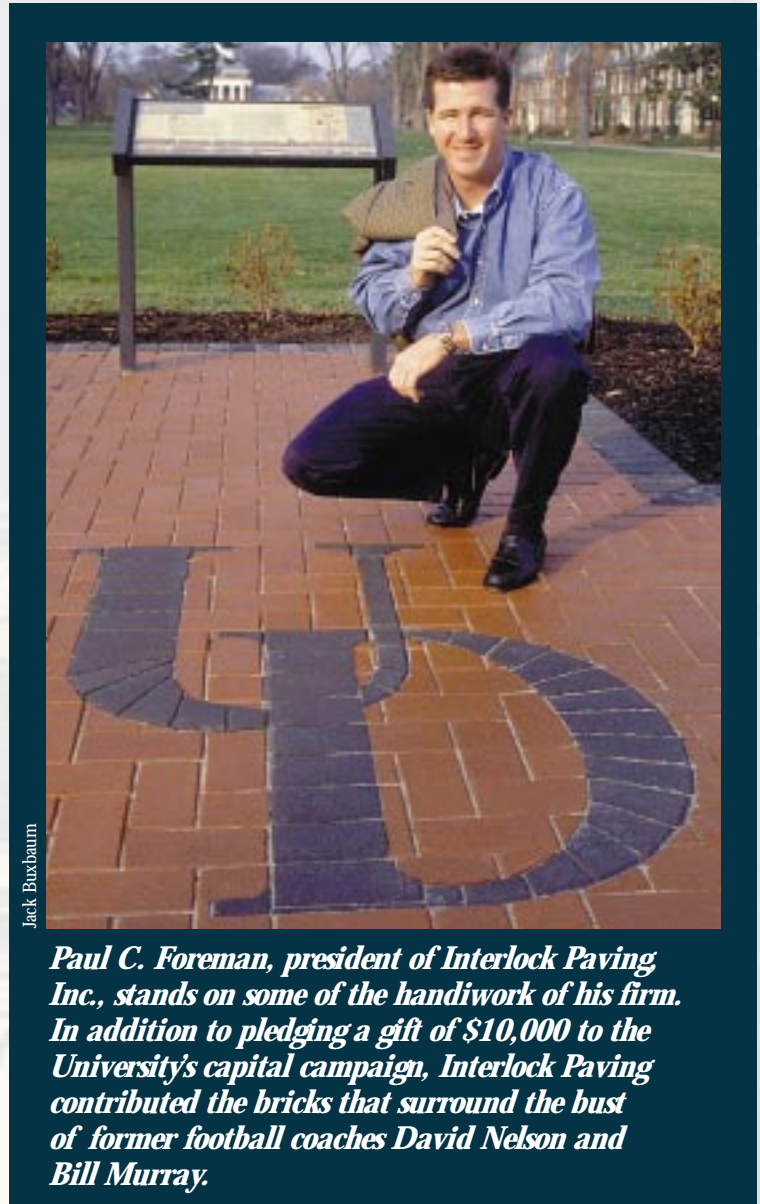

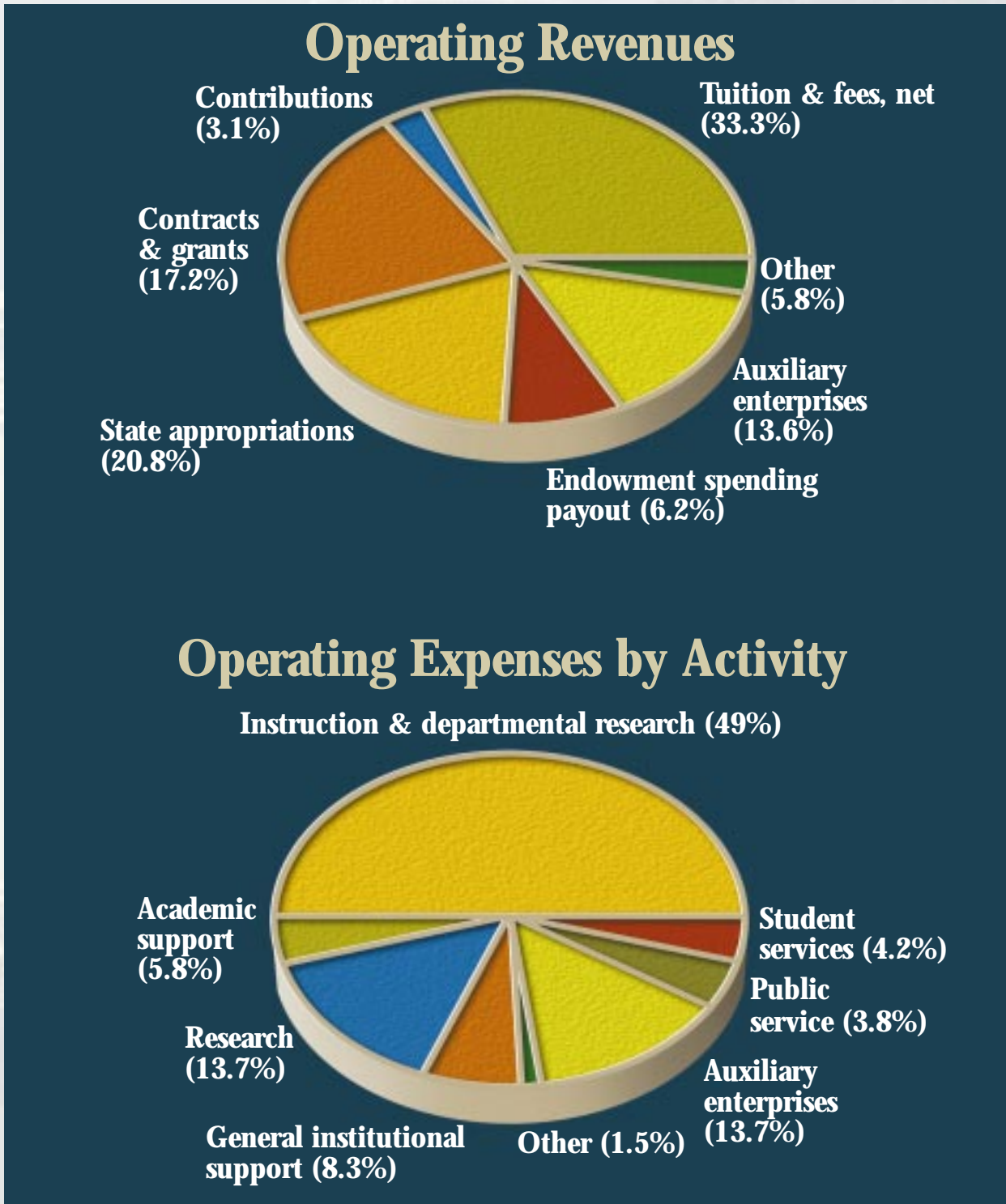

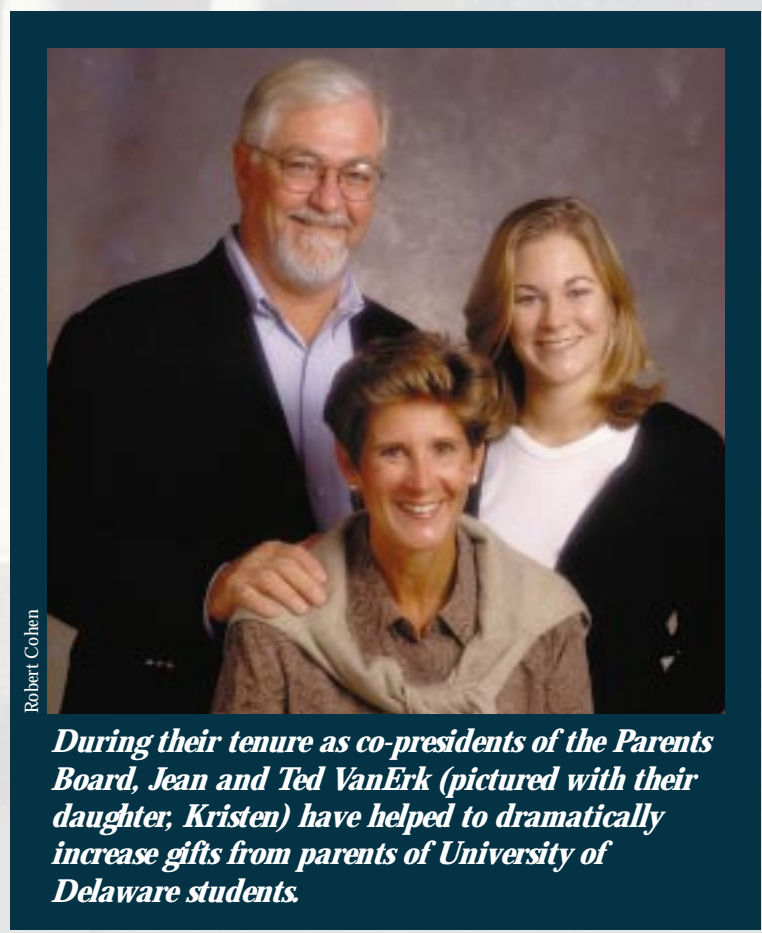
