U.S. Championships draw high ratings for NBC

Figure skating is successful in new primetime slot:

This is the first year of a multi-year agreement between NBC Sports and U.S. Figure Skating, after 43 years on ABC/ESPN. The seven hours were the most network coverage of this event since 1998, and the five hours of network primetime coverage were the most in a decade. Outside of Tiger Woods' final-round romp in the Buick Invitational at Torrey Pines, NBC's two primetime skating broadcasts -- Saturday (3.8/6) and Sunday (3.5/5) -- were the two highest-rated

sporting events of the weekend, even besting ABC's Sunday NBA doubleheader that featured the league's two marquee stars, Kobe Bryant and LeBron James.

US Figure Skating's Annual Governing Council was held in Denver on May 1 and 2. The opening guest speaker was Michelle Kwan who is currently a student at the University of Denver. She gave words of encouragement to skaters and thanked everyone in attendance for their support of her skating over the years.

In terms of business that was conducted, many items were discussed and voted upon by over 400 delegates. Some of the highlights are as follows:

1. Redesign of the Moves in the Field tests - this item was referred back to committee before it even was put before the delegates. Look for it to resurface next spring.

2. Coaches will be required to fulfill Continuing Education Requirements starting with the membership period beginning July 1, 2010. There will be 4 categories to apply yearly for as a coach depending on level of involvement in the sport from teaching Learn to Skate programs to coaching qualifying competition level skaters. Coaches can start to fulfill requirements starting July 1, 2008.

3. Adult competition age groups were altered, as were some of the time limits for programs.

4. Preliminary through Senior free skate tests will be allowed to have extra elements added *without penalty*.

5. Depending on if they are dance and/or free style judges, Bronze level test judges will be able to single panel pre-preliminary FS, pre-preliminary MIF, adult pre-bronze FS and MIF, and/or preliminary dance tests.

6. Change in judging of tests- If the *majority* of the judging panel requests a reskate, then the judge in charge will direct the skater to reskate the agreed upon element. This is to take effect immediately (previously any judge could ask for a reskate of an element, even if the other 2 judges did not wish for a reskate)
7. Pairs skating - new lists of required elements have been approved at all levels of pairs tests.
