Department Rules and Regulations:

A. Entries can only be made online via the Delaware State Fair's website beginning 9:00 AM April 1, 2022 thru 11:59 PM June 1, 2022.

- B. Any and all premiums may be adjusted by The Delaware State Fair Board of Directors based on funding sources.
- C. In order for the Delaware State Fair to better prepare for all exhibits, we ask that you only enter those classes which you will be able to complete and show at this year's fair. All 4-H activities use January 1st in determining age. Young people must be age 8 and older for all competitive events.
- D. All youth enrolled in the Delaware 4-H program are eligible to exhibit articles made as a part of project or activity work and participate in demonstrations, judging programs and other 4-H competitions outlined in this department of the Fair. An enrollment card or group membership form must be on file with the County 4-H Educator by March 1st of the current year.
- E. The Danish awards judging system will be used on all individual exhibits entered, except Section A, Section E (Class 115), Section I (Classes 177 & 178 only), Section O (Class 240), Section Q (Class 242), V, W, X, Y, Z, AA, and BB. All exhibits meeting the standards for first award will receive a blue ribbon and a cash prize. Exhibits receiving other placements will be given ribbons only.
- F. The building will be open between the hours of 9:00AM and 9:00PM daily during the Fair, **except for Saturday**, **July 23** when the building opens at 12 noon.
- G. Entries in the following exhibit areas must be delivered to the Fairgrounds between **3:00PM -6:00PM**, **Monday July 18**.

- H. The following exhibit areas must be delivered to the Fairgrounds between **8:30AM-11:00AM**, **Thursday July 21**.

 - 4. Cloverbud (Class 2 if live plant or vegetable and Class 7)
- The following exhibit areas must be delivered to the Fairgrounds between 10:00AM- 12:00 NOON, Wednesday July 27.
 - Cut Flowers
- J. Each 4-H'er must use the Delaware State Fair website to enter their exhibit on-line when entering Exhibits, Demonstrations Events, Judging Contests, Consumer Bowl, Avian Bowl, Public Speaking, Tractor Driving, Lawn Tractor Driving, Archery and Clothing Showcase. Entry deadline is June 1, 2022. Completed entry tags will be provided to the exhibitor to attach to exhibits. Please make sure your entry tag is ATTACHED TO YOUR EXHIBIT before entering the Fairground.
- K. 4-Hers—age 5 to 7, Cloverbuds, are eligible to enter **Section A ONLY**.
- L. All articles exhibited must be made or grown by 4-H member since last year's Fair.
- M. A youth pass will be given to 4-H Department exhibitors.
- N. No awards will be made for exhibits which do not meet minimum standards.
- O. Exhibitors may make only one entry in each class.
- P. No item should be entered by a 4-H member that cannot be displayed "as is" out on the display floor.
- Q. No premium will be awarded if an exhibit is not displayed.
- R. Every article exhibited should be labeled with name, 4-H county, age, year in project, club and class, in addition to the entry tag, to eliminate errors and lost articles. Please attach in such a way that it is not noticeable.
- S. Any exhibit included in a frame or on art canvas should include a hanger, wire or hooks for hanging. Hangers are not necessary for exhibits on poster board or mat board.
- T. If an exhibit includes a poster, posters are evaluated based on the following guidelines:
 - a. Should be simple, not wordy and provide a quick message in a concise format
 - b. Should be easy to read and have a single message / fact / point of interest
 - c. Letters and words should be clear, legible and straight
 - d. Neatness
 - e. Colorful
 - f. Use of visual or graphic is important
- U. All exhibits must be removed from the building between 8:00AM and 12:00 Noon Sunday, July 31. Every member MUST make arrangements for someone to pick up their exhibits if they are not able to do so themselves. There should not be an expectation for your exhibits to automatically be taken back to your respective county 4-H office.
- V. Care will be taken to protect the exhibits from injury, but the Delaware State Fair will not in any way hold themselves responsible for accidents, loss and damage by water, fire, theft or otherwise, whatever may be the cause or extent of the damage or loss sustained. All exhibits are entered at the owner's risk.
- W. Late entries will not be accepted.
- X. Questions regarding placing and/or premiums for the 4-H Department must be made in writing to the State 4-H office prior to September 15, 2022. Every effort will be made to eliminate errors during the payment of premiums. However, if an exhibitor finds an error, proof of such error must be communicated to the DSF office on or before November 1, 2022. After this date no corrections will be considered. Checks not cashed AFTER 90 days from issue will not be reissued.

Y. There are no separate classes for 4-H members for livestock or poultry. Please refer to Junior Division of the various departments for making your entries. Livestock Judging adheres to code of ethics found in the Livestock General Rules.

CANNING / DRYING EXHIBITS

Dried foods include fruits, fruit leathers, vegetables, herbs and dried beef, venison, poultry or fish (jerky). Each entry consists of at least 1 cup of product in an appropriate storage container. Label all entries with product, date of preparation, pre- and/or post-treatments, and method of drying.

All canning entries must be in standard canning jars. Please remove rings from jars before leaving exhibits. **Each entry (classes 59 to 74) consists of TWO JARS of like product**. One jar will be opened by judge. Arrangements can be made to return the opened jars of food. Contact your 4-H educator for details by July 1. Foods will be disqualified if only one jar is submitted and/or current USDA recommendations are not followed. Label all entries with product name, date of processing, type of pack, and method of processing. Incorrectly labeled exhibits will be rejected. The Delaware 4-H Foundation is gearing up for the holiday season by holding a holiday greeting card contest. All children ages 8 to 19 years of age are encouraged to submit an original design that celebrates the holiday season and Delaware 4-H.

Rules:

- 1. Submissions should be on 8.5 x 11 paper using landscape orientation. Exhibit must use entire space on page.
- 2. Any medium or combination of media may be used, including crayons, line drawings, watercolor, paint, etc.
- 3. No coloring book or traced drawings please.
- 4. Computer generated images **ARE NOT** acceptable.
- 5. Design **must** include the use of a 4-H Clover(s).
- 6. Do not fold entries.
- 7. Artwork may not be returned.
- 8. Avoid use of glitters or sparkles.
- 9. Please note that the design should celebrate the holiday season and not be specific to any religious celebrations.
- 10. Members may only submit one entry.
- 11. Artwork must be the artist's original creation.
- 12. The Delaware 4-H Foundation will award \$50.00 to the overall winner of this class; all other exhibits will receive a participation ribbon.

SECTION F

INDOOR / OUTDOOR GARDENING

Plants must have been in the care of the exhibitor for at least 60 days. Plants should be clean, free of insects, dead leaves, blossoms or broken stems. All containers should be cleaned. Plants are judged on plant health and overall appearance. All propagated plants should be propagated a minimum of 60 days prior to July 1st and done within the 4-H year.

SECTION H

PHOTOGRAPHY EXHIBITS

ALL PHOTOS in this section MUST be taken by the 4-H exhibitor. The 4-H exhibitor **SHOULD NOT** be in any of the photographs.

4-H siblings SHOULD NOT submit the same photo in any class. If this is done, the photographs will be marked down.

Mount individual photos on poster board, card stock, mount board or mat board; **not to exceed 6" x 8"** except where noted. Do not use foam board or construction paper. **Do Not staple photographs** to your mounting board. **Do Not Glue exhibit tag** to your mounting board. Use tape so it can be easily removed for displaying. Each photo must include the following on the back of every exhibit: camera type, brand, model and film size if film is used except where otherwise noted. Also, please note anything unusual about your picture (e.g. mounting, focus, subject etc.) that you think will help the judges to better understand your picture. For example, if you enter a picture of yourself or a picture with you in it, explain how you did that.

Judges will be asked to assess the entire exhibit. This includes not only the photograph, but also the mounting and any titles that are attached. Sloppy writing, glue on the mat, a poorly cut mat or crooked mounting all can detract from the photograph and lower the overall score.

Photographs in classes 135-159 and 160-166 may be taken using a digital camera, color film or black and white film (Classes 163 – 166 Only). Only one entry per class is permitted and each photograph may be entered only once in this entire section, including photos entered in the portfolio classes. The exception to this rule is in classes 160-162

(Digital Slide Shows), where only 50% or more of the images must have been taken during the past year. Photos entered in the digital slide show may also have been entered in other classes. Also, photos entered in class 153 (Best Photo Album) may have been entered as individual photos.

All photographs (unless otherwise noted in the rules above) must have been taken by the 4-H member since the beginning of the previous year's State Fair. Note that the name of each class indicates what the **primary focus** of that class should be. For instance, if you enter a picture of you with your lamb, and your primary focus of the photograph is the lamb, it should be entered in the animal category (and not people category).

Exhibitors SHOULD NOT enter the same photograph in the color photograph classes that are entered in the black and white photograph classes.

- 135. People Picture
- 136. Creature Picture: Any animal, insect, amphibian, fish or other living thing.
- 137. Landscape: A portion of land or territory which the eye can comprehend in a single view, including all the objects it contains.
- 138. Marinescape: A view of the sea.
- 139. Waterscape: A picture where the center of attention or dominant feature is on any body of water except the sea or ocean. Note: The fact that water is included in the picture is not enough.
- 140. Building Picture (any physical structure, house, public building, architectural photography)
- 141. Action Picture
- 142. Close Up (photograph should involve zooming/focusing in on a specific subject)
- 143. Special Effects Picture: A picture with some sort of a special effect such as a Hat Trick (a flowerpot or something else growing out of his or her head), Hand Stand (looks like one person is standing on another's hand), Magic or Bad Hair day. **The special effect used must be described on the back of the photograph.** See page 50 of Unit 1 of the 4-H Project Manual Focus on Photography for tips and suggestions.
- 144. Composition: Look for interesting shapes, patterns and textures. They can help create powerful images. Shadows and lighting are also important. Show one of the following: Depth of Field, Backlighting, Lines and Shapes.
- 145. Sunrises/Sunsets
- 146. Plants/Flowers
- 147. Still Life: Still life photos can be "created" (photographer arranged) or "found" (already arranged). **NOTE: For this category, ALL STILL LIFE PHOTO ENTRIES ARE REQUIRED to be "created"** which involves you arranging non-moving or still objects in an interesting way and then photographing them. Use a common theme in still life photos such as fruit, vegetables, flowers, toys or musical instruments.
- 148. Delaware History (with title): A photograph that shows some aspect of Delaware history with an attached title that explains the significance of the photograph. The entry could show a building or an event such as a parade. The title should describe the event and should be neatly handwritten or computer generated.
- 149. Delaware Scene (with title): Any picture taken in Delaware that shows a scene that is uniquely identifiable as being in Delaware. A picture of your dog in the backyard is not what we are looking for here. The title should describe the scene and should be neatly handwritten or computer generated.

- 150. The Delaware State Fair: A picture taken at the Delaware State Fair or involving some aspect of the state fair.
- 151. Patriotism: One photograph illustrating what patriotism means to you. It could be a picture of the flag, a parade or anything else. Be creative.
- 152. Delaware Agriculture / Delaware Farms: A picture depicting Delaware agriculture.
- **153.** Best Photo Album: Collection of photos taken by the 4-H'er (album must include a minimum of 25 photographs).
- 154. Digital Remastering: Single heavily edited digital image and the original image from which it was altered mounted on 8"x 10" mat board or poster board. Image has been radically digitally edited or enhanced. Some of the major types of mental illness are depression, anxiety, schizophrenia, bipolar mood disorder, personality disorders, and eating disorders. All youth/adolescents ages 11 to 19, are encouraged to submit an original design that helps reduce the stigma associated with seeking treatment for mental illness.

OTHER 4-H EVENTS AND ACTIVITIES

All 4-H activities use January 1 in determining age. Young people must be age 8 and older for all competitive events.

The **State 4-H Horse and Pony Show** will be held in the Quillen Arena on Friday, July 29 at 9:00 AM. The Horse Show is for 4-H club members of the Delmarva Peninsula and is sponsored by Delaware Cooperative Extension in cooperation with the Delaware 4-H Horse Advisory Committee. All participants must be bona fide 4-H club members in good standing **as of March 1 of the current year** and be able to present some form of 4-H identification as proof of membership.

- 4-H Exhibitors must be at least 8 years of age, but not yet passed their 19th birthday on January 1 of the current year.
- Cloverbuds are between the ages of 5-7 as of January 1st of the current year and receive participation ribbons only.

<u>Entries must be received in advance by July 15, 2022</u>. A class list and entry form will be available on the State 4-H website after May 1. Classes can be scratched or added up to and including the day of the show once they have entered. Entry fee payments are made the day of the show.

Horses and ponies may be shipped in the morning of the show or be stabled on the fairgrounds if they are participating in additional horse shows during fair week. Proof of a negative coggins test and a certificate of vaccination for Equine Influenza and Rhinopneumonitis (EHV) within the past 180 days are required to show. Exhibitors are required to wear an ASTM/SEI approved helmet whenever mounted or driving.

The **4-H Awards Celebration** will be held on Saturday, July 30 at 5:00 PM in the Quillen Arena. All Demonstration, Judging, Public Speaking, Archery, Avian Bowl, Consumer Bowl, Lawn Tractor, Tractor, State 4-H Horse Show and Conservation Display winners will be recognized. 4-H members and parents are encouraged to attend to be recognized.

4-H State Fair Floats – Each county 4-H program is invited and encouraged to have a 4-H float in the nightly Delaware State Fair 4-H Parade. All 4-H members are encouraged to ride these floats in this parade in an effort to promote 4-H at the State Fair.

GENERAL POLICIES FOR DELAWARE STATE FAIR EXHIBITORS

Parking

In an effort to be more safety conscious and to improve the appearance of the grounds, vehicles will not be allowed to park inside the fairgrounds property of the Delaware State Fair. Those livestock exhibitors who need to make deliveries to their exhibit area will be required to do so prior to 12 Noon each day. After 12 Noon, all vehicles will be required to park in the exhibitor lot or in the main parking lot. Violators of the parking policy are subject to be towed. All livestock exhibitors' owned cars parking in the exhibitor parking lot must display an exhibitor parking hang tag. Due to limited capacity in this lot, parking with a hang tag is on a first come - first served basis. Livestock trailers will be parked in a designated area in the south parking lot. Cars and trucks shall not be parked around barns.

Premiums and Awards

Every effort will be made to see that there are no errors made in the payment of premiums. However, if an exhibitor finds an error, proof of such error must be communicated to the Delaware State Fair Administration Office on or before October 1, 2022. After this date, no corrections will be considered. Checks that are not cashed after 90 days of issuance will NOT be reissued.

Advertising

No person will be permitted to distribute advertising material upon the fairgrounds except from their place of business or exhibit space. The tacking or posting of an advertisement, bills, etc., other than within the space occupied by exhibits is strictly prohibited. The distribution of handbills, flyers, and heralds will not be permitted under any circumstances. Anyone violating this rule is liable to fine or expulsion from the grounds. Begging, soliciting, singing, or public speaking is expressly prohibited.

Entry Removal

Entries MUST be removed by Sunday July 31, 2022. No exceptions. All items left will be discarded immediately after the Fair.

Pet Policy

With the exception of service animals, no pets are allowed on the grounds. Service animals as defined in the Americans with Disabilities Act (ADA) are permitted. Service animals are those that have been individually trained to do work or perform tasks for a person with a disability. Service animals are working animals, not pets. The work or task an animal has been trained to provide must be directly related to the person's disability. Animals whose sole function is to provide comfort or emotional support do not qualify as service animals under the ADA.

Bikes, Skateboards, Hoverboards, Segway, In-Line Skates and Wheelies

The operation of bikes, skateboards, hoverboards, Segway's, in-line skates and wheelies are expressly prohibited on the fairgrounds.

Electrical Extension Cords

In areas where the use of extension cords are permitted (ask your superintendent for clarification), cords used must be 12.3 gauge or heavier. There will be NO EXCEPTIONS to this rule.

POLICY REGARDING ACCOMODATIONS FOR EXHIBITORS

The Delaware State Fair, Inc. exhibitor program (i.e. livestock, competitive exhibits and contests) shall be accessible to the wide diversity of youth who live in our region, regardless of their backgrounds and characteristics — including physical, mental or emotional abilities and/or limitations.

Exhibitors with disabilities are entitled to be able to participate in the activities with their peers and any necessary accommodations must be made to make that possible. Any accommodation for an exhibitor with a disability should:

- 1. Allow an exhibitor with a disability to participate in the same collective activity as all other exhibitors at the same age level. Observation of the activity without direct involvement does not constitute participation.
- 2. Be determined with a stated goal to minimize direct adverse impact on how other participants in the activity perform or are evaluated. Every effort should be made to minimize the effects of the accommodation on other participants.
- 3. Be assessed on a case-by-case basis. The assessment and determination of the level of accommodation(s) should include consultation with the exhibitor, the exhibitor's parents or guardian, activity leader such as a Youth Program Advisor or Field Specialist, and a Fair program representative. Consultation with vocational rehabilitation professionals or professionals who teach or provide services to the exhibitor with the disability is also a preferred level of interaction to determine appropriate and reasonable accommodations.
- 4. Be reasonable. Accommodations are considered reasonable if they do not change the fundamental nature of the program or alter the essential criteria for participation. If an accommodation does not alter the fundamental nature of the program, then it is reasonable and will be provided. Exhibitors with disabilities will be judged using the same criteria as other participants. The accommodation should allow them to participate in the activity and achieve the criteria while not counting against the final determination of success.

Examples of possible accommodations include modifying rules, policies or timing of events; eliminating architectural or physical barriers; providing interpreters; modifying equipment; providing additional spacing needs; providing verbal or modified testing; allowing the use of digital technology (e.g. letter boards, text-to-speech programs or appropriate applications); or other types of accommodations as deemed appropriate.

The Delaware State Fair, Inc. respects the privacy of the individual participant. Information regarding an exhibitor's request for accommodation is extremely confidential. Any information that is gathered in order to assist the exhibitor in order to accomplish the goal of full program participation with accommodation will be used only for that purpose.

2022 COVID-19 GUIDANCE FOR EXHIBITORS

The 2022 Fair is planned with current Delaware Department of Public Health (DPH) COVID guidance in mind. This guidance could potentially impact your experience as an exhibitor in several ways.

COVID exposure is an inherent risk in any public location where people are present. Exhibitors should only attend after evaluating their own health risks.

- a. Entry on to the fairgrounds constitutes your understanding of these risks and your willingness to undertake the risk of exposure you while acknowledging that an inherent risk of exposure to COVID-19 exists in any public place where people are present.
- b. By participating in or attending the Fair, you and any guests voluntarily assume all risks related to potential or real exposure to COVID-19 and agree not to hold The Delaware State Fair, Inc., its directors, officers, employees, agents, contractors, or volunteers liable for any illness or injury.
- c. Exhibitors and family members are asked to refrain from attending the Fair if they have been in contact with anyone exhibiting COVID-19 symptoms within the last 14 days, have a fever or other symptoms, or if you fall into a high-risk category as defined by the CDC (without taking additional precautions as advised by the Delaware Department of Public Health and the CDC).
- d. The Fair encourages frequent handwashing by all exhibitors, their guests and family members and reminds every one of the importance of frequently washing their hands with soap and water. If soap and water are not readily available, you are encouraged to use a hand sanitizer that contains at least 60% alcohol is an acceptable alternative recognized by public health officials.
- e. The Fair will provide accessible handwashing and/or hand sanitizer stations throughout the fairgrounds.



4-H and FFA Foundation Buyback Policy



Policy for the Buyback of Animals Donated to the Delaware 4-H Foundation and/or the FFA Foundation From the Delaware State Fair Junior Livestock Auction




This policy sets forth guidelines for the purchase of animals donated to the Delaware 4-H Foundation or the Delaware FFA Foundation by buyers from the junior livestock auction at the Delaware State Fair. This policy does not govern the purchase of animals donated to individual 4-H Clubs, FFA Chapters or any other organization or person.

- 1. On the day following the junior livestock auction, at the Delaware State Fair (usually Friday), any junior exhibitor whose animal was purchased at the sale and donated back to the Delaware 4-H Foundation or the Delaware FFA Foundation may repurchase that animal between 9:00 a.m. and 11:30 a.m. in the 4-H Exhibit Area Office of the 4-H/FFA Building. Buyback prices are set at the discretion of the two organizations, as owners of the animals, and will be posted at that time. Payment must be made to the appropriate foundation at the time of the purchase. Exact payment must be made in either cash or check.
- 2. Any animal donated back to the Delaware 4-H Foundation or the Delaware FFA Foundation and not repurchased by the junior exhibitor between 9:00 a.m. and 12:00 p.m. on the day after the auction may be purchased by the general public. Sealed bids for available animals will be accepted between 1:00 p.m. and 3:00 p.m. that day. The minimum bid for any animal will be posted at the auction table in the 4-H/FFA Building at the Fair. The 4-H educator and a state FFA representative will open sealed bids at 3:00 p.m. Bidders will be notified by cell phone contact. Payment for all animals purchased by sealed bids must be made by 5:00 p.m. that day. If the bill is not settled by 5:00 p.m. the animal may be offered to the next highest bidder. Any animal not repurchased by either of these methods will be sold at the discretion of the foundation designees.

NOTE: Registration papers, if applicable, will not be collected by either foundation. Please make arrangements with the original owner to get the registration papers if they are available. Exact cash and check will be the accepted forms of payment.

ADOPTED FEBRUARY 22, 2022

STANDARDS OF BEHAVIOR: All exhibitors (livestock, competitive exhibits, FFA and 4-H) at all times while anywhere on the fairgrounds including but not limited to the show rings, barns, camping areas, carnival lot, competitive exhibit outdoor areas and buildings (i.e. Centre and Dover Buildings), commercial exhibit outdoor areas and buildings, parking lots, entertainment viewing and seating areas (i.e. concerts, wheel events, machinery lot, plaza and sponsor lot), the Roost, vehicular and pedestrian entry gates and indoor and outdoor facilities under management by Harrington Raceway and Casino (upon referral from casino management) are expected to maintain the following standards:

- 1. Behave in accordance with applicable rules, regulations and Delaware laws.
- 2. Follow the rules and regulations of The Delaware State Fair as they apply to exhibitors, campers, patrons and guests.
- 3. Treat all people on the fairgrounds fairly and with respect.
- 4. Respect the property of others.
- 5. Refrain from any physical or verbal altercations including unwanted physical contact.
- 6. Avoid the use of profane, abusive, and sexually explicit language.
- 7. Respect the authority of all fair personnel, judges, show officials, staff, volunteers and others in leadership roles and positions throughout the fairgrounds.
- 8. Accept responsibility for their personalchoices.

PROHIBITED CONDUCT: Exhibitor conduct of the type and nature listed below is considered unacceptable. This list is illustrative and should not be considered exhaustive:

- 1. Possession, use, or distribution of alcohol by or to a minor and/or showing signs of impairment.
- 2. Possession, and/or consuming any illegal drugs or misusing any controlled or unlawful substance and/or showing signs of impairment.
- 3. Trespassing upon or tampering with any fair buildings or other structures and improvements, commercial displays (inside or outside), outdoor equipment displays, carnival lot and equipment, circus performance area, animals and their pens, feed or water.
- 4. Theft or destruction of public or private property.
- 5. Any form of sexual misconduct.
- 6. Any form of verbal or physical harassment or abuse.
- 7. Possession of and/or use of any (a) weapon including firearms, knives, etc.; or (b) hazardous or dangerous materials including chemicals, explosives (i.e. fireworks).
- 8. Fighting or other acts of violence.
- 9. Unauthorized use of vehicles on the fairgrounds.
- **10.** Any other form of conduct determined to be a violation of the Delaware Criminal or Motor Vehicle Codes.

<u>PENALTIES AND SANCTIONS:</u> An exhibitor who engages in any of the prohibited conduct listed above, may, in the sole discretion of The Delaware State Fair, Inc., be subject to one or more of the following penalties and/or sanctions:


- 1. Notification of parents and/or guardians.
- 2. Forfeiture of and the return of premiums, prizes, awards and ribbons.
- 3. Disqualification and exclusion from the exhibition of livestock or competitive exhibits for current fair and/or future fairs.
- 4. Revocation of eligibility to participate in the Junior Livestock Auction for current fair and/or future fairs. Cancellation of an auction sale(s) and the return of the proceeds to the buyer(s).
- 5. Eviction of the exhibitor and his or her animals from the barns, grounds and the camping area.
- 6. Revocation of camping contract for the current fair and/or future fairs.
- 7. Banning from the grounds for a set period of time.
- 8. Criminal prosecution.

ENFORCEMENT Generally, but not exclusively, violations of this Exhibitors Code of Conduct are charged in a written citation or letter format prepared jointly by the department superintendent (i.e. any livestock department, competitive exhibits, 4-H or FFA superintendent) in consultation with one of the following: (a) the general superintendent of the appropriate operational division (i.e. Chairperson of the Livestock Committee (pertaining to all livestock, horse and ponies and poultry/rabbits matters); or (b) Chairperson of the Competitive Exhibits Committee (a/k/a the Dover Building Superintendent); or the Chairman of The Grove Management Committee. The citation and assessed penalty and/or sanction shall be considered final unless the exhibitor so cited properly and timely appeals the citation in accordance with the appeals process set forth below.

Exhibitors, parents and adult leaders are held to independent and severable rules, regulations and ethics codes (i.e. The IAFE National Code of Show Ring Ethics) applicable specifically to animal entries and competitive event standards, and which are separately set forth in the livestock handbook under the general rules and/or departmental pages. Violations of those rules, regulations and codes are handled distinctly and apart from violations of this Code of Conduct. Those violations have their own procedures and process for charges and appeals set forth therein.

APPEALS OF CITATIONS ISSUED UNDER THIS CODE OF CONDUCT

- 1. Appeals may be taken first to the General Manager. All appeals must be in writing using the Appeal Form set forth below and delivered to the fair office within 24 hours of receipt of the initial citation by the Exhibitor.
 - The General Manager shall issue a written decision on the appeal within 24 hours of receipt of the appeal by the office using the "Appeal Decision" portion of the Appeal Form and promptly transmit the same to the Exhibitor.
- 2. Thereafter, should the Exhibitor disagree with the appeal decision rendered by the General Manager, the Exhibitor shall complete the Final Appeal portion of the Appeal Form and deliver the same to the fair office within 24 hours of the Exhibitor's receipt of the General Manager's decision on appeal.
 - The Final Appeal shall be considered and decided within 24 hours by The Final Appeal Committee comprised of the President and 1st Vice President of the Fair's Board of Directors whose decision, when rendered, shall be final and not subject to any further action or appeal by the Exhibitor. The Final Appeal Committee shall issue a written decision on the appeal within 24 hours of receipt of the appeal by the office using the "Final Appeal Decision" portion of the Appeal Form and promptly transmit the same to the Exhibitor.
 - Penalties and sanctions shall be suspended during the pendency of an appeal should one be taken by the exhibitor.



EXHIBITOR'S RIGHT OF PROTEST OR APPEAL

Competitive Exhibits - Adopted February 21, 2022

Exhibitors have a right file a protest about another exhibitor whose eligibility as an exhibitor or whose particular exhibit allegedly does not meet the rules and regulations set forth by The Delaware State Fair. Also, an exhibitor has the right to file an appeal an appeal from a determination of the departmental superintendent that a particular exhibitor may have breached a department rule, regulation or ethics code applicable to department entries and/or set forth in the Dover Building departmental pages associated with all other competitive exhibits or competitive event standards. These protests or appeals will be considered by the Chairperson of the Fair's Competitive Exhibits Committee whichever is applicable and if appealed, ultimately by Fair management without fear of reprisal or recrimination as set forth below.

Exhibitors should use the following guidelines in expressing their protest or appeal.

- Please submit in written form a concise statement of your observations supporting your allegation that a
 person has violated a rule or the basis for your appeal in the case of the assessment of a penalty or sanction
 by departmental leadership. Provide as much detail as possible, and present the summary based on the facts.
 Hand-written documents are welcomed, but must bear the writer's signature. Anonymously written protests
 or appeals will not be accepted. Submission must be turned in to the Administrative Office within 24 hours of
 the occurrence of the incident giving rise to the protest or the assessment of the penalty or sanction. Upon
 receipt, the protest/appeal will then be forwarded to the appropriate individual (Competitive Exhibits
 Committee Chairperson and General Manager).
- 2. In no event should an Exhibitor's Right of Protest or Appeal form be filed after the end of current Fair. Protest and Appeal forms are also available at the Delaware State Fair's Administration Office. Please complete all required information fields including your name, address, cell phone, e-mail address, etc. along with the best means to contact you with the Fair's response. In the case of a protest, the name of the person alleged to have violated the rule and the citation of the rule violated must be included. A description of the exhibit involved (i.e. exhibit, class and division) must also be included.
- 3. It is critical that any protests or appeals be properly communicated in the fashion set forth above in a timely manner. It is imperative that all protests be brought to the attention of management while the Fair is underway so that all parties who might need to be involved in a resolution are on site and are able to participate in a quick and thorough review. A timely response will be made by management within 24 hours and communicated to the person who filed the protest or appeal.
- 4. Any opinion or decision rendered by the Chairperson of the Competitive Exhibits Committee may be immediately appealed within 24 hours to the Fair's General Manager, who in his or her discretion may consult with any additional parties needed to render a decision. The General Manager's decision on a protest or appeal shall be made and communicated within 24 hours. The decision of the General Manager shall be considered final.
