





Delaware 4-H enrollment and re-enrollment starts on September 1, 2019.



Re-enrollment procedure for CURRENT 4-H members and leaders:

1. Please complete your re-enrollment through "4-H Online" by visiting the State 4-H website, <u>http://extension.udel.edu/4h/</u>, and clicking the green "4-H Online" button at the bottom of the page. Once you have successfully logged into your family record and selected the member record you want to re-enroll, go to the bottom of the record and click the enroll button for this year.

2. If you were enrolled in 4-H last year, but cannot remember your password or family email, please DO NOT create a new profile. Click on "Forgot Password" and create a new one. When you create the new password, you will then be asked to go back into your original profile and re- enroll that way.

IMPORTANT NOTE: As part of your re-enrollment process, please review the answers on the health form and make the necessary changes/updates to reflect the current status of your child's health and insurance information. **Enrollment procedure for NEW 4-H members:**

1. The prospective new 4-H member will contact the county office/club leader to ascertain club and project information. This communication is required before the new member processes any new enrollment information online.

2. Once the club has been selected with the assistance of the county office/club leader, the new member can process their enrollment online. This enrollment process can be completed by visiting the State 4-H website at http://extension.udel.edu/4h/ and clicking on the "4-H Online" button on the bottom of the page.

IMPORTANT NOTE: If you created a FAMILY RECORD last year for your other child/children, please **DO NOT CREATE ANOTHER FAMILY RECORD** as this will create a duplicate record in the system. You will just add a new youth member under the already existing FAMILY RECORD umbrella.

Enrollment procedure for NEW 4-H volunteers:

The application process to become a NEW Delaware 4-H volunteer is very straightforward and includes the following steps in this order:

1. The prospective new 4-H Volunteer will contact the respective Organizational Club Leader of the club for which they want to serve as a 4-H Volunteer. This communication is required before the new volunteer processes forms or enrollment information online.

2. The volunteer will complete the Volunteer Application and submit it to the County Office.

3. The Volunteer will receive notification from the County 4-H Educator of successful approval of University of Delaware background hiring process. **NOTE:** All new volunteers MUST pass the background check before they can be approved as a volunteer and work alone with youth in the 4-H club.

4. The Volunteer will process their enrollment online. This enrollment process can be completed by visiting the State 4-H website at <u>http://extension.udel.edu/4h/</u> and clicking on the "4-H Online" button on the bottom of the page.

5. The Organizational Leader will provide formal confirmation of enrollment to the new volunteer. After each of these steps has been completed successfully, the new volunteer may begin their work with 4-H youth in a club setting. If any one of these steps has not been completed and formal approval not granted by the County 4-H Educator, the volunteer applicant cannot be in an unsupervised situation with any 4-H youth. The volunteer's involvement must be limited strictly to activities where other approved 4-H volunteers are present, and the applicant must commit to inquiring on their own behalf as to their final status.

Social Well-being Challenge – 100 points

Incorporate a TEAM BUILDING ACTIVITY into a club meeting. Social relationships are an integral part of our wellbeing and help us establish a sense of belonging. Building relationships among club members is a great avenue for establishing a productive club and a safe space for all members to gather.

Personal Well-being Challenge - 100 points

This bonus is about personal well-being and how we can grow ourselves through our passions, interests, and aspirations. To achieve the bonus, have your club take part in an activity that has members exploring their dreams and establishing a goal for this month or whole year. After members have established their own goal, consider having them discuss a TEAM GOAL they want to work on as a club this year.

• Vision Board: Have youth bring old magazines to meeting. Each youth has a piece of paper and collects images or text from different magazines that represents their interests and dreams. Have them decorate it and then share an aspiring goal that they have.

• **Interest Maps:** Give youth a sheet of paper and have them write down all their interests, connecting ones that have similarities. If they see a pattern in their interests, have them focus in on that area and establish a goal.

Emotional Well-being Challenge - 100 points

Emotional well-being is emotions, feelings, and awareness or focus on their inner self. The U.S. Department of Health & Human Services explains Mental and Emotional Wellbeing is "essential to overall health. Positive mental health allows people to realize their full potential, cope with the stresses of life, work productively, and make meaningful contributions to their communities. Early childhood experiences have lasting, measurable consequences later in life; therefore, fostering emotional well-being from the earliest stages of life helps build a foundation for overall health and well-being."

Introducing opportunities for youth to learn about their emotional well-being is an important component of our 4-H programming. Take time during your club meeting to incorporate a technique that will help youth build their emotional wellbeing.

Here are some example ideas of activities/conversations to have to meet the Emotional Well-being Challenge:

• Have a conversation about anti-bullying: What do they see at school? How can they help others feel included? How can they address a bullying situation next time they experience or witness it?

- Open your club meeting with 4-H Yoga which incorporates yoga poses with each verse of the 4-H pledge.
- Self-compassion exercise with "I am..." statements: have youth write down 2-3 statements "I am" Acknowledging their strengths and attributes they recognize in themselves.

Financial Well-being Challenge – 100 points

Our awareness of financial health can have an impact on how we think, feel, act, and share with others. This challenge will introduce ideas and strategies to increase the strength of our financial literacy. Learning skills early on can help prepare for the future when finances become a staple part of our daily life.

• Savings

- Strategies to Save: Based on your needs or wants, make mini banks to take home and start saving for your goals. Have members bring small mason jars or recycled plastic bottles, decorate and label for your different needs and/or wishes. (ex: Fun with Friends, Car, Clothes, Movies, Summer Fun, Savings etc.)
 - Experts recommend that we save a small percentage of the money we earn to put into savings. Encourage your youth to talk with their parents about a savings account if they don't already have one

Environmental Health Challenge – 100 points

One area of well-being we may not often consider is how our physical and natural environments impact our personal and public health. This can include access to safe routes to be active, nutritious foods that are affordable, safe water to drink and maintaining healthy environments where our food is grown. It is important that we consider how we treat our environments so that we have sustainable access to our basic human needs for generations to come.

Consider one of the topics below to discuss at your club meeting to learn more about the importance of our environment and how that can impact our health:

- Where our food comes from: This activity will help you consider where foods in our diet come from. Are they "local" or do we depend on agriculture from greater distances? Consider how distance of transportation for foods may impact our physical environment and discuss strategies to produce and purchase more local foods.
- **Invasive Species:** Learn about weeds and other species that interrupt or inhibit the safety of growing plants we need and food production we seek.
- **Pollinators:** Discuss with your club the role that bees and other pollinators play in food availability.
- **Decluttering our space:** Our environment can also include our personal space. The space we are in can impact our emotional health and decluttering our space helps declutter our mind of negative thoughts, emotions and feelings.

• Nature Hike: Take a hike through the woods or down the sidewalk in the neighborhood your club is meeting in. During this hike have youth note the things they see (different plants, bugs, animals, people, etc.). Afterwards, debrief on how they feel after getting some fresh air outdoors and encourage members to get 60 minutes of physical activity each day and try to get those minutes while outdoors if possible. *This could count towards physical activity challenge too!

Community Well-being Challenge – 100 points

This challenge is take what you have learned and share it with others. Think of a way you can share healthy living with people in your county to help them live a healthier lifestyle.

Here are a few examples:

- Build a raised bed at a nursing home so residents can garden from a wheelchair.
- Create posters promoting healthy choices and place around town.
- Present to your families, a community organization, or your school about making healthy changes.
- If you have a community parade or event, create a float or display about healthy living.
- Ask local farmer's market if you can set up a display to promote fruit and vegetable consumption.

Include a short description and/or picture of your club completing the BONUS challenges in order to earn the extra points.

Clubs that participate will be recognized at county achievement events to celebrate their success!

Participation Requirements

- Youth Participants must be a member of a 4-H Club, 4-H Archery Club, 4-H Shooting Sports Club, or a County 4-H Shooting Sports Program where during the club year they have received archery instruction from a certified Delaware 4-H Archery Instructor.
- Adult Participants must be a Parent/Guardian, Adult Sibling or Family member of a participant or a 4-H Leader/Volunteer.





General Equipment Rules

- 1. Contestants will use their own archery equipment and arrows.
 - a. If a contestant needs equipment we can make arrangements for equipment to be available for use, but these arrangements must be made in advance.
- 2. All equipment will be inspected for safety, condition, etc. by field officials prior to the match and at any time during the match when inspection is merited.
- 3. If equipment is found to be unsafe and corrections not made before the match, then the contestant will NOT be able to compete and will forfeit their registration money.
- 4. Maximum bow weight allowed in any division is 60 pounds. This will be checked before the match. Bows above the maximum draw weight must be modified and re-checked.
- 5. A nocking point indicator is required to position the nock of an arrow on the string. The nocking point indicator may be of any conventional design, including materials that may be crimped, wound or heat shrunk to the center serving.
- 6. An arrow must be released off of a felt arrow shelf, whisker biscuit or other arrow rest. (Overdraws may not place the arrow rest further than 6cm from the pivot point of the bow.)
- 7. At full draw, arrows must extend beyond the back of the bow. Clickers will be allowed.
- 8. Arrows consist of a shaft with a target or practice point, nock, fletching and personal identification markings. Arrows must be sound and spined for the bow.
- 9. Each archer must provide an adequate number of arrows to complete the event.
- 10. Release aids may be used only by compound shooters. Competence with the equipment must have been demonstrated before the release aid may be used.
- 11. Each archer must wear and use arm guard and finger protection.
 - a. No glove or bare finger shooting is not permitted.
- 12. DRESS CODE: Normal 4-H dress code applies.
 - a. Closed toe shoes are REQUIRED.
 - i. Crocs are NOT closed toe shoes.
 - b. Long Pants HIGHLY recommended.
- 13. Each archer will be required to use a hip/clip-on arrow quiver ONLY.
 - a. Bow mounted, or quivers worn on the back are NOT permitted.
- 14. ALL participants must attend mandatory safety orientation meeting prior to match.
- 15. Minimum arrow weight is 5 grains per 1lb of draw weight.
- 16. Bow stands are not provided, but can be used.
- 17. Since the Field and 3D ranges are combined range finders are **NOT** permitted on the Field/3D range at all.
 - a. Possession of one is grounds for disqualification.
 - b. Binoculars are allowed.
- 18. Spotting scopes may be used on the FITA range as long as they do not interfere with another archer. If they do interfere with another archer, youth will be asked to move the scope off the line by the Range Officer.





3D Information and Rules

3D animal targets, examples: Deer, Strutting Turkey, Wild Boar, & Coyote.

Distances:


Junior 4-H'ers - known distances up to 20 Yards. Intermediate 4-H'ers - known distances up to 35 Yards. Senior 4-H'ers and Adults - unknown distances up to 50 Yards.

Time Limits:

Shooters will move through the course expeditiously and avoid delays. A maximum of 2 minutes will be allowed for searching for passed arrows.

Scoring:

IBO based Center Vital Zone Ring = 11 points Second Vital Zone Ring = 10 points Third Vital Zone Ring = 8 points Any other body shot = 5 points (Not Antlers/Horns) Clean miss = 0 points (includes witnessed glance offs)



An arrow embedded in the horn of an animal, not touching body color, is considered a miss and is scored as a zero. Targets with legs or hooves of a different color than the main body will still be considered as body color for scoring.

When shooting with your squad, all archers should be spotting for the archer shooting to assist with looking for arrows that miss, as well as to judge "*Glance Offs*" or "*Bounce Backs*".

Glance Offs are defined as a shot arrow that hits the target, but doesn't stick in the target and "Glances" off continuing beyond the target. When this occurs and is witnessed, the score of the arrow is 0. The archer is NOT entitled to re-shoot the target in this case.

Bounce Backs are defined as a shot arrow that hits the target and "Bounces Back", not going into the target, and not traveling beyond the target. When this occurs and is witnessed by the squad, the archer - is permitted to re-shoot the target with another arrow.

If a re-shoot is granted by the squad, the Archer must make the shot prior to any of the Archers within the squad approaching the target.

If their is a dispute within the group on if it is a "*Glance Off*" or a "*Bounce Back*" the target host on the course will contact a Range Officer and they will work with the squad and help resolve the issue(s).

Bows are to be left in bow stands or on the ground near the Target Host when going to Score and Retrieving Arrows from the Target.





Field Information and Rules

Targets:

National Field Archery Association (NFAA) targets of sizes selected by the management and appropriate to the course. All of the targets are set at marked distances. Instructions will be posted at each target and a Target Host is present at each target to answer basic questions.

Distances:

Junior 4-H'ers - known distances up to 20 Yards. Intermediate 4-H'ers - known distances up to 40 Yards. Senior 4-H'ers and Adults - known distances up to 60 Yards.



Bows are to be left in bow stands or on the ground near the Target Host when going to Score and Retrieving Arrows from the Target.

Kent County 4-H Community Service Awards

Sponsored by the Kent County Order of the 4-H Links

In an effort to recognize Kent County 4-H members for their volunteer service in the community, the Kent County Links will award certificates to all 4-H members who have completed their respective required hours of community service work. Youth who have met this level of community service work, should complete the fillable form to provide detailed information related to the member's activities and total number of community service hours completed.

The form is due typically in mid-September, for the 4-H year that just completed, September 1-August 30.

Youth ages 11 and under (including Cloverbuds): 25 Hour Requirement Youth 12 and up: 50 Hour Requirement

How to Apply: Complete community service log which can be found on the Kent County 4-H Website

Deadline: Typically due in September of the each 4-H year

Awards are presented at the Kent County 4-H Achievement Banquet to 4-Hers who have participated in worthy community service events.

Prudential Spirit of Community Award

In addition to the Kent County Links sponsored award, the Prudential Spirit of Community Award will also be presented to the top 4-Her(s) in both the middle level (grades 5-8) and high school level (grades 9-12). The community service log will be used to select these recipients; no additional submission, to be considered for this award, is required.

There are several factors to consider when judging applications:

Initiative: Did the applicant initiate the activity(s) or show exceptional leadership in an existing one?

Effort: How much time did the activity(s) require? Did the applicant overcome any significant obstacles?

Impact: Were many people affected by the activity(s), or were individuals impacted in a major way?

Personal growth: Did the applicant gain insights or skills from the activity? Did he/she demonstrate a sound understanding of the value of service?

Additional information if needed

Community Service or Volunteer Service Hours are the compilation of time your student spends doing things for other people. If it counts for a school credit/grade, you cannot also count it as time spent volunteering, since you've been compensated. If your kids are paid for it, directly or indirectly, it does not count. Just participating in an extracurricular activity does not count. There is a difference between service and donations. **General donations**,

collections or drives to benefit local causes will not be accepted as service hours unless you are providing the leadership to organize it or going above and beyond.

Here are some scenarios:

If 4-Her mows your elderly neighbor's lawn, or carries in groceries or shovels their snow, it counts. If they are paid by the neighbor, it doesn't. If they mow your lawn, it does not count as that is just part of being a family and they benefit financially from that arrangement.

If they are a musician, time spent playing a benefit performance for a charity would count (as well as time to prepare and commute). Regular practice time does not count.

If they attend a 4-H meeting, it does not count. It does count if they are leading the meeting (which benefits other 4-Hers), teaching / demonstrating, organizing trips, buying supplies for other 4-Hers, spending a week as an unpaid counselor at camp, etc. In the case of a counselor, count the waking hours when they were responsible for other campers. The planning time for an event that benefits others is also appropriate to count.

Athletes do not count practice, games, or paid refereeing. Coaching a younger student, setting up conditioning practice for the team, volunteering to work a tournament, etc. would count. Mentoring or teaching younger youth would count as community service. Attending a clinic does not qualify, teaching at a clinic does.

Leading a Bible study or mentoring younger students counts, as does setting up or tearing down for an activity. Performing in a church program is not considered community service. Preparing a meal for another family in crisis would count.

Volunteer babysitting to assist a family in need counts. Watching their own younger siblings does not. Training for first aid or CPR counts; but not if it is required for a paid job.

Helping at voter registration or a polling place counts; but helping a candidate or a cause does not count

Fundraising is not acceptable to count as community service hours. If you are raising funds for your club to provide community service at a later date, count the time/service when you actually execute that activity. For example, if your club raises funds and the funds are spent on making tray favors for the nursing home at the holidays, you would count that time it took to make the favors and related activities. If your club uses the funds to go to the Pennsylvania Farm Show, you would not count that. Exchange fundraisers are not considered community service. Time selling raffle tickets is not considered community service.

Members assisting a disadvantaged person with a chore (cleaning out their garage, gardening, repairing their home, etc.) counts, but helping a family member or any able-bodied person with a chore does not count.

Some activities that have been submitted in the past, that do not count as community service

- Hosting a foreign exchange student or family; or Interstate Exchange
- Helping a family member or any able-bodied person with a chore does not count; for example cleaning stalls/volunteering at a local farm or helping to haunt the local attraction is not community service...
- Garage sales although you may <u>help</u> someone if they are holding a garage sale and all the proceeds are going to charity
- Adopt a Family at the holidays or gift buying for the holidays... these are great donations but not service.
- Teaching Health Rocks or Up for the Challenge or any other program where youth are compensated
- Running/Walking in a 5K or any other type of donation is not considered community service
- Hosting breakfasts or dinners for the purpose of fundraising as well as working snack stands and food booths, with the exception of the approved service organizations listed below

Acceptable examples of Community Service:

- Coastal Cleanup or Adopt-A-Highway
- Litter Barrel and Window Display, Trim-A-Tree (be accurate with your reporting here)
- Making food /Assembling Care Packages
- Haunted Hallways not donating candy but attending the event
- Assisting at 4-H events (Holiday Fun Day, Fav Foods, Fashion Revue, DSF, Hall of Fame, State Teen Conf., Basket Auction, etc)
- Making / Delivering Tray Favors; Making centerpieces for a non-profit
- Making Hats/Scarves; Filling Holiday Stockings; Filling Shoeboxes
- # Collections, Drives if you are the leader/organizer (donations themselves are not community serv)
- Assisted and/or Handed out ribbons at a livestock or horse show
- Yard work for someone who is unable to do it for themselves
- Assist as a junior leader at the Livestock Overnighter or serve on the Livestock Advisory Committee and regularly attend planning meetings.
- Training for first aid or CPR counts
- Members assisting a disadvantaged person with a chore (cleaning out their garage, gardening, repairing their home, etc.); helping at a local mission
- Volunteer time at a 4-H display booth, not collecting funds, lead a craft, talk to passer-bys, provide demonstrations, educating public. Must be engaging. Standing at a table is not considered service.
- Vacation bible camp volunteering counts
- Ringing the Salvation Army Bell
- Volunteer time to the following approved service organizations; Ruritan, Elks, Moose, Delaware Farm Bureau, Delaware State Grange, 4-H Foundation (not local club), FFA Foundation (not local chapter), Delaware Food Bank, Relay for Life, Special Olympics or your local Firehouse. Volunteering at Fifer's IF you are educating or presenting some type of display.
- * Offering a petting zoo for a non-profit event/organization or providing a nativity scene
- Helping at voter registration counts or a polling place counts
- Solution of the service of the servi
- A committee member: time in meetings, time spent shopping; time at event (Great Pumpkin Day, Holiday Fun Day, Favorite Foods etc.)
- Younger Member Weekend or Day Camp Counselor: Time at the event and time planning are appropriate to count
- # Junior Project Leaders: Time spent teaching other 4-Hers is appropriate to count
