Associate Dean for Diversity and Inclusion, College of Health Sciences (Summer 2016 – present)

As the Inaugural Associate Dean for Diversity for the College of Health Sciences, I lead the development and execution of diversity and inclusion initiatives. In this role, I aim to (1) expand and support diverse recruitment of students and faculty, (2) provide training for diverse recruitment, (3) expand the diversity of our undergraduate and graduate student pipelines, (4) increase the inclusiveness of our existing academic opportunities, (5) monitor and suggest enhancements to a diverse and inclusive health sciences curriculum, and (6) support community-based initiatives in diverse local communities. Drawing partly from the University's strategic goal to "build an environment of inclusive excellence" and University-based resources such as the Office of the Vice Provost for Diversity, UD ADVANCE, and the Center for the Study of Diversity, the following are a few highlights of some of our most impactful initiatives:

- Employee and student inclusion and climate initiatives. During my tenure I have developed and led three signature inclusion and climate initiatives. Ongoing Conversations is a recurring discussion among graduate students and employees that tackles a DEI topic and promotes tough conversation around the topic. To date we have had College-wide conversations focused on providing safe spaces for discussions about race, White privilege, using White privilege for allyship, and expanding perceptions of the "look" of professionalism in the workplace. The second initiative, Healthcare Theatre Social Justice Training, uses live actors to act out scenarios that reflect microaggressions and overt discrimination in the classroom and workspaces and requires audience members to enter the theatrical scene to act on behalf of the victim of the act and/or diffuse the situation. Lastly, we have held a number of College-wide conversations with community partners to promote university-community partnerships that service the local patient community and support community-based research efforts.
- Undergraduate pipeline programs. Our team has developed three primary undergraduate pipline programs: Health Sciences Summer Camp, dual enrollment high school courses, and high school/undergraduate mentoring. We also offer comprehensive, experiential tours of our laboraties and clinics for middle and high schools to learn more about the College. By working with local high schools we are growing and diversifying the pipeline of students that enroll in the College of Health Sciences. We are able to offer advisement resources and some financial support for our pipeline students that decide to join our College as freshmen.
- Faculty search committee training/consulting. Each fall, I lead a faculty search
 committee diversity training that is required of faculty on search committees and
 incorporates best practices for reducing implicit bias. I also provide search committees
 with vital resources for evaluation of candidates, planning job interviews, and mentoring
 strategies. I also meet with underrepresented faculty candidates to discuss the university
 and any questions related to being an underrepresented faculty member on UD's
 campus.
- Expanded graduate student recruitment efforts. I have initiated and led a team of faculty
 and staff that are actively recruiting underrepresented minority undergraduate students
 for our graduate programs. With a presence and engagement at national conferences
 such as the Annual Biomedical Research Conference for Minority Students (ABRCMS)
 and the Society for Advancement of Chicanos/Hispanics and Native Americans in
 Science (SACNAS) Conference, we are highlighting and marketing our excellent
 graduate programs with a broader reach. We are also expanding our recruitment efforts
 at historically black colleges and universities (HBCUs) in the region and marketing to
 minority-serving institutions.
