Further, I agree to defend, indemnify and hold harmless the University from any and all claims, demands and/or causes of action arising out of my own actions while participating in the Program.
- Photo, Video, and Audio Recordings. I understand that photographs and/or video or audio recordings may be taken of me in connection with my participation in this travel study program. I hereby grant the University the right to use, reproduce, copy, publish, or distribute any and all such images and audio for the purpose of publicizing University programs or for any lawful purpose. Further, I agree to hold harmless and release and forever discharge the University and its agents, employees, and representatives from all claims, demands, and causes of action which my heirs, representatives, executors, administrators, or any other persons acting on my behalf have or may have, including those relating to copyright ownership, publication, privacy and publicity, and any claim for compensation related to the use of any such materials.

The invalidity or unenforceability of any provision of this Agreement and General Release shall not affect the validity or enforceability of any other provision of this Agreement, which shall remain in full force and effect.
