# Other Sources of Aid

- State Grants (Need Based)
  - Eligibility
    - Based on financial need as determined by the FAFSA
    - State chooses qualifying students
  - Action Required
    - FAFSA submission
    - May require verification (check To Do List)
  - Renewability
    - Varies based on state criteria
    - FAFSA completion and similar financial need
- Outside Scholarships
  - Payments should be sent directly to Student Financial Services for processing and crediting to student account
  - Unless indicated otherwise, scholarship will be split between Fall and Spring Semesters.
  - Most outside scholarships are sent during SFS's busiest times. Please note these take time to process and you may use the Additional Credit process in My Finances for scholarships not already showing as disbursed or pending.

# Other Loans

- Federal PLUS Loan (Parents)
  - Eligibility – Parents can borrow up to educational budget, less other aid (may require credit-worthy cosigner).
  - Action Required – FAFSA submission and Master Promissory Note ([www.studentloans.gov](http://www.studentloans.gov))
- Private Educational Lenders
  - Eligibility – Students can borrow up to educational budget, less other aid (may require credit-worthy cosigner).
  - Action Required – Apply directly through the lender (a sampling of lenders is available on the Loans page at [www.udel.edu/sfs](http://www.udel.edu/sfs)).

# Work-Study

- Eligibility
  - Based on financial need as determined by the FAFSA
  - Provides opportunity for students to earn wages
- Action Required
  - FAFSA submission, may require verification (check To Do List)
  - Apply and be hired for work-study positions (jobs are posted at [udel.joinhandshake.com](https://udel.joinhandshake.com)) in order to work and earn funds
- Renewability
  - Federal Standards of Academic Progress
  - FAFSA completion and similar financial need
  - Varies based on availability of funds



# Verification

- Federal verification is a review process through which UD must verify the accuracy of the information provided on a student's FAFSA, as required by federal regulations.
- FAFSAs are selected by the federal processor for verification.
- Families will be notified via email if selected for verification and any required items will also show up on student's To Do List.
- If selected, students will be required to upload requested documentation into My SFS Docs, UD's document collection system.

# Verification

- Federal funds require completion of verification, if selected, before UD can disburse those funds to student account.
- Financial aid awards may change if tax and/or household data reported in the original FAFSA is inaccurate and corrections must be made via the verification process.
- Families should complete verification now in order to have funds disbursed at the start of classes.
- Students and families should check the To Do List to ensure all requested information has been submitted. Additional documentation may be required through this process.
  - Students use My SFS Docs to securely submit required verification documentation

# The To Do List

- Provides information and links to action items needed to finalize financial aid disbursement.
- Examples include master promissory notes and verification items.
- Viewable in My Finances or UDSIS.
