What Are Financial Holds?

Placed on accounts with balances over \$1,000



Prevents registration to future terms

Avoids balances from automatically doubling with registration



Hold Removal

- Holds come off at 4:45 pm each day for balances at \$1,000 or less
- 2 pm are credited the following business days
- pay to the student's account

• Payments made before 2 pm process the same date; payments made after Those borrowing to cover balances should allow 10-14 days for loans to



Course registration for fall/spring is not just a point in time

Winter/Summer Registration

- Begins same date/time for \bullet everyone
- Stays open until free drop/add of session



Registration

Spring/Fall Registration

- Staggered approach ightarrow
- Seniors with most earned credits first ullet
- Then by class level and earned credits •
- Student not guaranteed of course ightarrowavailability if registering at appointed time
- Registration remains open until after free ulletdrop/add

2025 Summer Registration – Free Drop/Add March 31– June 9

2025 Fall Registration – Free Drop/Add April 14– September 9



Billing Cycle

Remaining Spring installment* due date: • April 3

- Financial holds
 - March if not on installment plan
 - April 7 if on installment plan

Future term billing

- Summer mid May notification Due June 9
- Fall undergrad mid July notification Due August 1 (Installments Sept/Oct/Nov 1*)
- Fall grad/PCS early August notification Due August 26 (Installments Oct/Nov 1*)

* Installment option available on *Make a payment* screen in My Finances and incurs \$50 fee per term



SFS continues to process outside scholarships and loans.

- Parent PLUS & private/alternative loans processed in order received
- Half pays to fall and half to spring for fullyear loans
- PLUS current through 3/19/25
- Alternative loans current through 3/19/25



Financial Aid -Current Status

- Outside scholarships processed in order received
 - Ensure student name and ID are included on check and send to:

Student Financial Services 30 Lovett Avenue Newark, DE 19716

- Split evenly between fall and spring semesters unless directed otherwise by the donor.
- Current through 3/14/25



Financial Clearance:

- All funding (aid, waivers, etc.) is recorded on the student account or reported to SFS and any remaining balance has been paid
- Incomplete To Do List items will delay payment of aid
- Ensure reported credits have been paid to UD

Common To Dos:

- Federal loans must complete Master Promissory Note for student or parent borrowers and Entrance Counseling for students
- Free Application for Federal Student Aid (FAFSA) – required for consideration of federal grants, as well as federal student or parent loans
- Federal verification required before aid can be finalized and paid to student account
